Online Applications are invited from Eligible Indian Nationals for direct recruitment to the following posts of Junior Engineer (Trainee) against vacancies in Distribution Companies(DISCOMS) viz, Madhyanchal Vidyut Vitran Nigam Limited, Poorvanchal Vidyut Vitran Nigam Limited, Pashchimanchal Vidyut Vitran Nigam Limited, Dakshinanchal Vidyut Vitran Nigam Limited, Kanpur Electric Supply Company(KESCO), U.P. Power Transmission Corporation Ltd.(TRANSCO) and UPPCL Corporate offices under **Uttar Pradesh Power Corporation Ltd.** (UPPCL) as detailed below. No other mode of submission of application is available or acceptable.

Other provisions and instructions required for filling of Online Applications are given as under:

2. (a) Applicant should apply for one post only. (b) Physically Handicap candidates are not eligible for above posts. (c) Candidates availing the facility of reservation under any category should clearly mention the category applicable. Under any circumstances, change of data will not be allowed after successful submission of completed Application Form. However submitted application form can be viewed and downloaded/printed. If at any stage it is found that the information furnished in the online application form is false/fake/misinterpreted/incorrect, or does not satisfy the eligibility criteria for the post applied, the candidature is liable to be cancelled, even after appearing in the Examination, in addition to any other action as may be deemed fit.
3. **Pay Scale :** Pay Band-2; Pay scale -Rs. 9300-34800 ; Grade Pay- Rs. 4200; Dearness and other allowances admissible as per rules of UPPCL.
4. **Essential Qualification :**
(A) Candidates should have thorough knowledge of Hindi (Devnagri script). If the candidate has not passed High school or equivalent examination in Hindi, he/she has to clear an exam conducted by the Registrar, Department Examination Govt. Of U.P. within 3 years of joining. (B) A candidate must have passed (i) "Three years Diploma examination in Electrical Engineering/Electronics Engineering/Telecommunication Engineering/Civil Engineering awarded by Pravidhik Shiksha Parishad, Uttar Pradesh OR a Diploma, equivalent thereto, recognized by the State Government" OR (ii) "Three years All India Diploma Examination in Electrical Engineering/Electronics Engineering/Telecommunication Engineering/Civil Engineering conducted by the All India Council for Technical Education (AICTE), Govt. of India" OR (iii) "Diploma Examination in Electrical Engineering/Electronics Engineering/Telecommunication Engineering/Civil Engineering conducted by any of the Universities in India incorporated by an Act of the Central/State legislature."
Note:- (1) Candidates having received Diploma through Distance Learning Education Programme are Not Eligible to apply for the above posts. (2) Candidates having Diploma received on the basis of length of service (without passing the Diploma examination) are also Not Eligible to apply for the above posts.
5. (A) **Age :** Minimum 18 years and maximum 35 years as on 01-01-2013.
(B) **Relaxation in upper age limit:** (I) Apprenticeship training under Apprenticeship Act 1961 -Actual period ,subject to maximum **Twenty four months** . (II) "SC, ST & OBC (non-creamy layer)" of Uttar Pradesh domicile-**5 years** (III) Ex-Servicemen who had served a minimum of 5 years in Armed Forces of India-**(Service years + Three years)**. However maximum age of a candidate availing all relaxations shall not exceed **50 years**.
6. **Reservation :** (I) Reservation will be provided as per applicable Reservation rules to "SC, ST and OBC (non creamy)" candidates who are original inhabitants of Uttar Pradesh (Domicile of Uttar Pradesh only). (II) "SC, ST and OBC" of other states & OBC (coming under '**creamy layer**' of U.P.) may apply as General Category candidate.(III) Horizontal reservation for "Ex-Servicemen (EXSM)" will be provided as per existing UPPCL order.
7. **No Objection Certificate :** Candidate who are working with any State Govt./Central Govt./Semi-Govt./ Govt. Undertaking organization ,shall have to submit 'NOC' from their present Employer at the time of Joining.
8. **Examination center & Selection Process :** Selection Process will be based on written Test(Computer Based Test (CBT)) and Interview. Computer Based Test (CBT) will be held at **Allahabad, Varanasi, Gorakhpur, Agra, Kanpur, Bareilly, Lucknow, Ghaziabad, and Meerut cities** .Electricity Service Commission, however, have the right to cancel any of the Examination City/ Center and/or add some other cities/centres depending upon the response, administrative feasibility, or any force-majeure conditions etc.. The test shall be of **total 200 marks** and shall comprise of total 200 questions, out of which 150 questions shall be from the Diploma level Engg. Branch syllabus for the Post applied, 20 questions of General Knowledge/Awareness, 20 questions of Reasoning and 10 questions of General Hindi. **Each**

correct answer shall carry one mark each and each wrong answer shall carry negative mark of 0.25. Candidates of General/OBC who obtain less than 33% marks in CBT and SC/ST candidates who obtained less than 28% marks in the CBT will not be eligible to be considered for selection. Interview carrying **35 marks** will be conducted at Lucknow only. Maximum numbers of candidates shortlisted for interview will be equal to 3 times the number of vacancies in each category. However, in case a number of candidates obtain equal marks, which are the minimum marks for being called for interview, all such candidates will be called for interview. Appearing in both the CBT and interview is compulsory; failing which candidature will be treated as cancelled. Finally, the merit list shall be prepared on the basis of the combined marks obtained in the CBT and interview, branch wise category wise.

* CANDIDATE MUST CARRY (i) ADMIT CARD, (ii) PASSPORT SIZE PHOTOGRAPH (SAME AS IN THE APPLICATION FORM) AND (iii) A VALID PHOTO IDENTITY CARD SUCH AS PASSPORT, DRIVING LICENCE, VOTER ID, AADHAR CARD, PAN CARD OR ANY OTHER VALID PHOTO IDENTITY PROOF (Same as mentioned in the Application Form) WHILE REPORTING FOR CBT AND INTERVIEW.

* CANDIDATES ARE REQUIRED TO MAINTAIN THEIR UNIQUE E-MAIL ID AND MOBILE NUMBER THROUGHOUT THE SELECTION PROCESS.

* IF AT ANY STAGE, IT IS FOUND THAT ANY INFORMATION FURNISHED IN THE ONLINE APPLICATION IS FALSE / INCORRECT OR THE CANDIDATE DOES NOT SATISFY THE ELIGIBILITY CRITERIA FOR THE POST APPLIED, THE CANDIDATURE WILL BE TREATED AS CANCELLED.

* Candidates having undergone apprenticeship training under Apprenticeship Act 1961, will be given age relaxation and preference as per order of Hon'ble Supreme Court, in case, all other requisite parameters being the same.

9. **Training:** The selected candidate has to undergo a training programme, for a period as decided by UPPCL. On successful completion of the training, the candidate shall be considered for absorption as per existing rules of UPPCL.

10. **Transparency:** For the complete transparency of the held CBT, the Electricity Service Commission shall arrange to display the answer-key for 7 days on the official website of UPPCL, after the interviews are over. The date of display of answer key will be displayed on the official website of UPPCL. The candidate can lodge their protest online, if any, along with proper proof within 3 days from the last date of display. Electricity Service Commission will refer the cases to a panel of experts, whose decision shall be communicated. After the expiry of this period, any objections shall not be entertained.

NOTE:-

12. **Character :** Candidate will have to produce character certificate issued from the Head of the last Institute attended and also from two responsible/ respectable persons who should not be his/her relatives at the time of joining.

13. **Marital Status :** Any married male/female candidate having more than one wife/husband alive and female candidate who is married to a person who has already one or more living wife, are **NOT ELIGIBLE** to apply for above posts.

14. **How to apply :** **Application Form (Part-A & Part-B), Payment mode selection and other general details are available at UPPCL official website www.uppcl.org** Candidates are advised to Login the website and select "VACANCY/RESULT " and follow the instructions carefully given therein step by step, for completing and **submission of Application Form.**

15. **Candidates should apply for one Post only.** Computer Based Test (CBT) for all the posts will be conducted simultaneously. All the candidate, who, have completed and submitted the form, shall be provisionally allowed to appear in CBT on basis of their particulars provided in the Application Form Part-A (which does not necessarily mean eligibility). Complete form with uploaded particulars will be scrutinized subsequently. If at any stage, it is found that the information furnished in the online application form is false/fake/misinterpreted/incorrect or does not satisfy the eligibility criteria for the post applied, their candidature are liable to be cancelled, even after appearing in the Examination, in addition to any other action as may be deemed fit by ESC.

16. **Submission of documents :** All concerned and relevant **original** documents viz Caste certificate, domicile certificates, date of birth certificate, Technical essential qualification certificate/final marks sheet , apprentice certificate, certificate of 'Ex-Servicemen in Armed Forces of India' shall have to be submitted for verification alongwith a self attested copy of each document at the time of interview . **Failing to produce these qualifying documents at the time of interview in original will result in conditional rejection of the candidature.**
