Applications are invited from eligible female candidates who are citizens of India for recruitment for the following posts in Arunachal Pradesh Police (Civil Police). The details are given herein after:-

**2. AGE ELIGIBILITY:-**

Sub-Inspector	The age of candidate should be between <b>20 to 25</b> years as on <b>01-01-2013</b> .	Relaxation of upper age limit for APST & SC/ST candidates is given up to maximum of 5 (five) years and 3 (three) years for OBC candidates
Constable	The age of candidate should be between <b>17 to 21</b> years as on <b>01-01-2013</b> .	

**3. PHYSICAL STANDARDS:-**

Height (for both Sub-Inspector & Constable)	152 cm	157 cm

**NB:** The candidates should be free from physical deformity/infirmity like squint eye, knock knee, bow leg, dismembered fingers and any other physical deformity/infirmity which is likely to cause impediment to performance of active duty in police force. The candidates with such deformity/infirmity will be rejected during the Physical standards Test (PST).

**4. CENTRES FOR RECRUITMENT:-** The recruitment for both the posts (Sub-Inspector & Constable) will be conducted centrally at Itanagar by separate Boards on "separate dates".

**5. EDUCATIONAL QUALIFICATION:-**

Lady Sub-Inspector	Graduation in any discipline from a recognized University as on the date of submission of application form.
Lady Constable	Minimum educational qualification required for all candidates is Class-X passed from recognized government institution/board as on the date of submission of application form.

**7. SCHEDULE OF RECRUITMENT:-**

- i. **Receipt of applications:** Duly filled up application forms addressed to "**Asstt Inspector General of Police (E), PHQ, Itanagar, PO Itanagar PIN: 791113 Arunachal Pradesh**", along with attested copies of certificates of educational qualification, proof of age as per school certificate/Admit card/Birth registration certificate, Caste/Tribe certificate, Permanent Residential Certificate (PRC) and 4 (four) recent passport size(3:4cms) colour photographs with self signature on them (one affixed on the application form at space provided and 03 (three) nos securely enclosed in an envelope) and self addressed reply envelop affixed with postage stamp of Rs. 5/- will be received w.e.f **03/06/2013** at PHQ Itanagar on all working days. A treasury challan of **Rs. 15/- for APST candidates & Rs.60/- for General candidates** for the post of Sub-Inspector and **Rs.10/- for APST candidates & Rs.40/- for General candidates** for the post of Constable, in favour of Asstt Inspector General of Police (E), PHQ, Itanagar under Head of Account "0055" Police, should be also enclosed.

*The application forms can either be sent by ordinary post or directly submitted by hand at PHQ Itanagar.*

*The envelope containing application form should clearly mention post applying for (APPLICATION FOR POST OF SUB-INSPECTOR OR APPLICATION FOR POST OF CONSTABLE).*

- ii. **Last date of receipt of applications:** "**30/06/2013**". No application shall be accepted after expiry of last date of submission i.e., **30/06/2013** up to 1600 hrs.
- iii. **Scrutiny of documents, Physical Standard Test (PST) and Physical Efficiency Tests (PET):** Scrutiny of the documents, Physical Standard Test (PST) and Physical Efficiency Tests (PET) (qualifying in nature) shall be carried out at 1<sup>st</sup> AAP Bn Ground Chimpu, Arunachal Pradesh. The eligible candidates shall be issued call letters informing the date of Scrutiny of the documents, Physical Standard Test (PST) and Physical Efficiency Tests (PET).

**NB: The candidates will be required to bring along the originals of the documents/ testimonials submitted along with application form at the time of scrutiny of documents for verification &**



*authentication. The candidature shall be summarily rejected on non-production of original documents during scrutiny.*

- iv. **Written Examination:** Written examination shall be conducted centrally at Itanagar, Arunachal Pradesh for only those candidates who successfully qualify the physical efficiency tests. The dates and venues will be notified separately for this purpose.

**8. SELECTION PROCEDURE:-**

- i. **PHYSICAL ENDURANCE/EFFICIENCY TEST:-** The short listed candidates whose application/documents are found in order in all respects and who are found fit in Physical Standard Test (PST) will be put through physical efficiency test in the following events (both for Sub-Inspector & Constable).

Sl. No.	Event	Minimum qualifying standard
1.	100 mtrs. Race	19 seconds
2	800 mtrs race	5 minutes
3.	High Jump	90 cms (in three attempts)
4.	Long Jump	9 feet (in three attempts)

**NB:** *The physical efficiency/endurance test will be qualifying in nature. However, candidates who do not qualify the minimum qualifying standard in any of the above events shall be treated as "disqualified" for the written examination/interview.*

- ii. **WRITTEN EXAMINATION:** - The eligible candidates of physical efficiency test will be put through written test in the following subjects (to be held separately for Sub-Inspector & Constable).

**NB:-**

- a. The written examination will be of Multiple Choice Objective Type question paper on OMR format answer script.  
b. The minimum pass marks in written examination will be 45% in aggregate and 33% in each subject  
c. There will be no negative marking.

- iii. **INTERVIEW:** - The candidates scoring higher marks in written test in order of merit will be called for interview/viva voce at the ratio of 1:3 with respect to the vacancies. The date, time and place will be announced separately by the police department. **Total marks for the interview will be 40.**

- iv. **MERIT LIST:** - The final merit list of the selected candidates will be made on the basis of overall marks secured in the written test and interview put together.

- v. **MEDICAL EXAMINATION AND CHARACTER & ANTECEDENT VERIFICATION:-** Appointment of provisionally selected candidates shall be subject to clearing a medical examination conducted by a medical board and satisfactory verification of Character & Antecedent.

*Though police department shall arrange first aid at recruitment centre for emergencies, the department shall not be responsible for any personal damage/injury to the candidates during the recruitment process/physical endurance efficiency test.*

*No TA/DA will be admissible to the candidates for attending in the recruitment process. The candidates shall have to bear their own expenses and arrange for their boarding/lodging on their own.*
