**Advertisement Notice for recruitment to the post of Senior Resident & Junior Resident doctors on regular basis.**

Applications are invited for appointment to the under mentioned posts of Senior/Junior Residents doctors at Guru Gobind Singh Govt. Hospital, on regular basis. Application forms can be obtained from the office of the Administrative Officer., GGSG Hospital between 10.00 A.M. to 03.00 P.M. **from 12.06. 2013 to 14.06.2013** by paying Rs. 500/-(in cash) to the cashier for Unreserved and OBC Candidate. ( Form is free for SC/ST & Persons with disabilities Candidates)

Duly filled up application forms with attested copies of testimonials as mentioned in eligibility criteria, can be submitted in the office of the Medical Supdt., GGSG Hospital between 10.00 A.M. to 03.00 P.M. from **12.06.2013 to 14.06.2013.** Interview of eligible candidates will be held from 10.30 A.M. in the Conference Hall, 2<sup>nd</sup> floor Ward Block of this hospital for Senior Residents and Junior Resident as per dates mentioned below.

For appointment against posts reserved for SC/ST/OBC category: only candidates having OBC certificate issued by the Competent Authority of GNCT of Delhi shall be eligible. For SC/ST's: SC/ST certificate issued only from the Judicial/Revenue Authorities as per notice in MHA OM No. 42/21/49/NGS dated 28-01-52 as revised by the Deptt. of pension and AR letter No. 36012/6/71/Estt.(S.C.T.) dated 29-10-77, shall be accepted. For persons with disabilities candidate: 3% reservation under section 33 of the Persons with disabilities Act. 1995 will be followed as per Govt. of India Rules.

Candidates who are working on adhoc basis will have to apply afresh.

**ELIGIBILITY FOR THE POST OF SENIOR RESIDENTS:**

1. **QUALIFICATION:** MBBS with P.G. Degree/Diploma/DNB in concerned specialty from a recognized university/Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & ad hoc period.
2. **Age limit:** 40 years for General candidates, 45 years in case of SC/ST & 43 years in case of OBC candidates & for persons with disabilities further relaxation of 10 years as per provision, on the closing date for submission application.
3. **Pay scale:** Rs.15600 - 39100/- (Grade Pay-6600/-) plus admissible allowance.

The appointment will be made initially for a period of one year and will be extended further on yearly basis upto a maximum of 03 years, on the basis of satisfactory Work & Conduct Report from the concerned HOD and a written request from the Doctor concerned. Senior Resident may be asked to do duties in Emergency Deptt. as & when required in case of exigency.

In case where no fresh candidates are available, candidates who have completed 03 years of Senior Residency and are willing to serve as SR, shall be allowed to appear in the interview. A separate merit list will be prepared for fresh candidates and for those candidates who have already completed 03 years of Senior Residency. The fresh candidates would be called first for appointment.

**ELIGIBILITY FOR THE POST OF JUNIOR RESIDENTS:**

1. **Qualification:** MBBS Degree from a recognized University/BDS Degree from a recognized University and must possess valid Registration Certificate from DMC/Delhi Dental Council.
2. **Age Limit:** 40 years for General candidates, 45 years in case of SC/ST & 43 years in case of OBC candidates and for persons with disabilities further relaxation of 10 years as per provision, on the closing date for submission application.
3. **Internship:** Must have completed one-year rotatory internship by closing date of application.
4. **Pay Band:** Rs.15600-39100 (Grade Pay- 5400/-) plus other allowances as admissible.

**Note: The no. of vacancy of SRs/JRs may vary**

The post of Junior Resident is a tenure post; Appointment will be made initially for a period of 06 months and shall be further extended upto maximum duration of one year on the basis of satisfactory Work & Report from the concerned HOD and a written request from the Doctor concerned. JRs would be liable to be posted in any department of hospital according to exigency of work and service.

Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any Junior Resident beyond one year appointment.

Post Graduate Doctors who are interested to serve as Junior Resident will be allowed to join as JR if fresh graduates are not available.

1. The hostel accommodation is compulsory for JRs, subject to availability.
2. No TA/DA will be paid for appearing in the interview.
3. The number of vacancy of SRs/JRs may vary
