NOTIFICATION FOR ENGAGEMENT OF DRIVERS ON CONTRACT BASIS ON A MONTHLY CONSOLIDATED REMUNERATION IN APSRTC : RANGA REDDY REGION

Applications are invited from the eligible candidates for engagement on CONTRACT BASIS to the post of Driver on a MONTHLY CONSOLIDATED REMUNERATION IN APSRTC RANGAREDDY REGION.

The number of posts, reservations, remuneration & qualifications are as follows

REMUNERATION: Rs.7,180/- per month

NO.OF POSTS: 123

RESERVATION OF POSTS.

- First 20% of the Posts will be filled from among the Common Merit List of LOCAL & NON-LOCAL candidates and the rest of the 80% posts will be filled purely with local candidates.
- 33.33% are reserved for WOMEN
- 29% are reserved for BCs (7% to BC A, 10 % to BC B, 1% to BC C, 7% to BC-D% and 4% to BC E
- 15% are reserved for SC
- 6% are reserved for ST
- 2% are reserved for EX-Servicemen

QUALIFICATIONS & OTHER ELIGIBILITY CRITERION

- Must hold a valid LICENSE of Heavy Passenger Motor Vehicle (HPMV) &
 Heavy Goods Vehicle (HGV) or Heavy Transport Vehicle (HTV) for a period of
 not less than 18 months excluding the periods lost due to late renewals or
 License Suspension etc., if any, as on the date of selection.
- 2. Must be able to read and write a Regional Language (ie. TELUGU or URDU)
- 3. Must not be less than 160 CMs height
- 4. Must be above 22 yrs and below 35 yrs as on 01.07.2013
- 5. The Upper Age Limit is relaxed by 5 years for SC/ST/BC Candidates

- 6. Ex-servicemen, who are former members of Defence Services of the Indian Union will be permitted to count the period for which they have held a Military Heavy Duty Vehicle License towards the period. For such persons, the age limit will be relaxed up to 45 yrs.
- 7. PHC Candidates are not eligible to apply for these posts.

SALE & SUBMISSION OF APPLICATIONS

- The Application Forms will be on sale from 25.11.2013 to 10.12.2013 at all the Depots of the APSRTC: RANGAREDDY Region i.e., HYD-I, HYD-II, PKT, TDR, PRG, VKB and MGBS/HYD on all working days from 11.00 hrs to 17.00 hrs on payment of Rs.100/-(Rupees one hundred only) for each application form.
- 2. The last date for the sale of application forms is 10.12.2013 up to 17.00 hrs.
- 3. The OC candidates have to pay a fee of Rs.100/- towards processing fee.
- 4. SC, ST, BC & Ex-Servicemen are exempted from payment of processing fee.
- 5. Application forms sold by outside agencies or Xerox copies of the applications will not be accepted.
- 6. It may be noted that one candidate should not submit more than one application for a post.
- 7. The receipt of filled in applications starts from 25.11.2013 onwards. The last date for submission of filled in applications by the candidates is 11.12.2013 up to 17.00 hrs.

The candidates should enclose the attested copies of the following certificates

- 1. Date of Birth Certificate,
- 2. Educational qualification
- 3. Driving Licence-certified Xerox copy
- 4. Integrated Caste Certificate (if the Integrated caste Certificate is not available, a certificate issued by Revenue Authority issued within 6 months should be attached)
- 5. Local Area Certificate issued by Revenue Authority
- 6. Discharge Certificate in respect of EX-Servicemen
- 7. Money Receipt for the processing fee of Rs.100/- for candidates other than those belonging to SC/ST/BC/Ex-Servicemen categories.
- 8. Two (2) passport size photos and two (2) self addressed envelopes of size 20 cms x 10 cms.

SUBMISSION OF APPLICATION: The candidates should submit the filled in

Application forms only at the Unit/place from where they have been purchased. For example-If a candidate purchases application form from TANDUR Depot, he has to submit the filled in application form at TANDUR Depot only with all the prescribed enclosures mentioned above and processing fee, if applicable.

Applications by the candidates sponsored by the Employment Exchanges:

The candidates who have registered their names with the employment exchange and have been sponsored to these posts and the ex-servicemen who are sponsored by the District Sainik Welfare Board shall also purchase application form from the specified counters on payment of Rs.100/- and submit the same along with all required enclosures including MR for Rs.100/- towards processing fee (in case of OC candidates only) within the stipulated time. No further information will be given to these candidates with regard to submission of applications.

Selection Procedure for the post of Drivers:

The selection will be done by conducting a driving test. After scrutiny of the applications by screening committee, all the eligible candidates shall be called for driving test.

The selected candidates shall enter into an agreement on a Rs.100/- non-judicial stamp paper at the time of engagement with the Depot Manager concerned.

The selection of the candidate is subject to medical fitness as per the standards fixed by APSRTC.

The selected candidates will be given training as per APSRTC procedure and they shall incur the expenditure on their own for attending training.

The engagement on contract basis in the same Region is final. In case of exigency, they may be engaged in the other Regions.
