[Abbreviations Used: - GEN-General, SC-Scheduled Caste, ST-Scheduled Tribe, OBC-Other Backward Class] Horizontal reservations for Ex-servicemen and Persons with disability (PWD) are available (with 40% and above relevant disability)

(a) Category-wise number of vacancies mentioned above are purely provisional and subject to variation without notice.

(b) Reservation for Physically Handicapped / Challenged fall under the category of horizontal reservation which cuts across vertical reservation i.e., reservation for SC/ST/OBC (in what is called inter-locking reservation). The people selected against the Physically Handicapped / Challenged quota have to be placed in the appropriate category of General / SC/ST/OBC, as the case may be.

(c) Reservations are applicable as per existing govt. rules issued from time to time

**2. Eligibility Criteria.** Posts are to be filled by direct recruitment of Apprentices through selection of candidates holding National Apprenticeship Certificate(NAC) in the relevant trade issued by the National Council of Vocational Training. Other qualifications being equal, preference will be given to ex-apprentices of Dockyard Apprentice School of the Indian Navy

**Essential Qualifications**

(a) Matriculation or equivalent from recognized Institute or Board with knowledge of English.

(b) Should have complete apprenticeship training in the trade **(or)** Mechanic or equivalent with two years regular service in the appropriate Technical Branch of the Army, Navy and Air force.

### 3. Age For Direct Recruitment/ Age Relaxations

Between 18 and 25 Years, applicable to both direct recruits and ex-Naval apprentices with relaxation as under:-

- (a) Relaxable for Government servants upto thirty five years in accordance with instructions or orders issued by Central Government from time to time.
- (b) Relaxable by 03 years for OBC, 05 years for SC/ST, 10 years for PHC candidates against reserved vacancies.
- (c) Relaxable to apprentices to the extent of the period for which the apprentices had undergone training

**Note:** The age limit will be calculated as on the closing date for submission of online recruitment applications on the web site

### 4. Selection Process.

All eligible candidates, whose applications are registered online, will be short listed for a written examination consisting of objective type questions prepared based on the syllabus of the relevant discipline and at the discretion of the competent authority. Selection of candidates will be purely based on the performance in the Written Test and the Merit List drawn category wise thereof.

### 5. Guidelines for Filling Online Application.

(a) Eligible applicants are required to apply through 'On-line application Format' available on ND(MBI) recruitment website [www.godiwadabhartee.com](http://www.godiwadabhartee.com).

(b) No application through other mode will be accepted. No Original documents are required to be sent to Naval Dockyard, Mumbai along with the application.

(c) Before registering/submitted applications on the website the candidates should possess the following:-

(i) **Valid E-Mail ID.** The e-mail ID entered in the online application form should remain active until the recruitment process is completed. No change in the e-mail ID will be allowed once entered. **After receipt/acceptance of application, intimation about date, time and venue for written examination will be intimated to candidates by e-mail or Admit card or website [www.godiwadabhartee.com](http://www.godiwadabhartee.com)**

(ii) **Photograph.** While applying On-line, candidates should keep the scanned copy of their latest passport size color photograph and their signature in digital format (.jpg or jpeg file only, each less than 50 kb size) for uploading with application.

(d) After applying online, candidates who fulfill all eligibility criteria will be able to download the registration/application form generated by the system with unique registration number. The same is to be retained for future reference and **ONE COPY OF REGISTRATION/APPLICATION FORM AND ADMIT CARD IS TO BE BROUGHT AT THE VENUE OF EXAMINATION ALONGWITH FOLLOWING CERTIFICATES / TESTIMONIALS IN SUPPORT OF AGE, EDUCATION QUALIFICATION, TECHNICAL QUALIFICATION DULY ATTESTED BY GAZETTED OFFICER viz**

**(e) AFORESAID DOCUMENTS ARE REQUIRED TO BE SUBMITTED AT THE VENUE FOR VERIFICATION AND RECORD FAILING WHICH APPLICATION OF THE CANDIDATE WILL NOT BE CONSIDERED.**

- (i) The SC/ST candidates should also submit latest copy of caste certificate duly attested by a Gazetted Officer for claiming age/other relaxation alongwith Registration Slip and produce original certificate on demand.
- (ii) OBC candidates are required to submit copy of caste certificate, which inter-alia must specify that the candidate does not belong to 'creamy layer' issued by the Competent Revenue Authority not below the rank of Tahsildar/Mandal Revenue Officer/ Revenue Divisional Officer as prescribed vide OM No. 36012/22/93 – Estt (SCT) dated 08 Sep 93 as amended vide OM No. 36033/3/2004/Estt(Res) dated 09 Mar 2004.
- (iii) Ex-servicemen should enclose undertaking as per GOI/DOP&TOM/36034/ 29/Estt/SCT dated 03 Apr 1991.
- (iv) The person with disability who want to avail benefit of reservation and age relaxation, have to submit disability certificate issued by the competent authority in the format Annexure I of GOI/DOP&T OM 36035/3/2004-Estt(Res) dated 29 Dec 2005.

**6. General Instructions**

- (a) Only Indian Nationals can apply for the above post.
- (b) Before applying for the post, the candidate should ensure that he/she fulfills the eligibility and other norms mentioned in the advertisement. Furnishing of wrong/false information will be a disqualification and this Dockyard will not be responsible for any consequences of furnishing of such wrong/false information.
- (c) The eligibility with respect to age, educational qualification, etc will be determined as on the closing date for online registration
- (d) Candidates employed in Govt. departments must produce "No Objection" Certificate (NOC) at the Examination venue from their employer. In case, the candidate fails to produce the NOC, his/her candidature will not be considered.
- (e) The written test will be conducted at Mumbai only.
- (f) The vacancies upto the date of declaration of the final result will be considered at the discretion of Admiral Superintendent, ND(MBI).The vacancies are subject to variation and the Admiral Superintendent has the right to cancel the advertisement/recruitment at any stage due to administrative reasons.
- (g) The candidates who have applied for selective trades in the order of preference will be considered for any of the trades from their basic feeder trade to the extent of availability of vacancies.
- (h) Candidates are liable to serve in any Naval Unit within Western Naval Command and the decision of the competent authority is final and binding.
- (j) Candidature of the registered candidate is liable to be rejected at any stage of recruitment process or after recruitment or joining if any information provided by the candidate is found to be false or is not found in conformity with eligibility criteria mentioned in the advertisement.
